5. Electronic bids must be submitted through the PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs on July 20, 2018. Bids received after this deadline will be rejected.
6. The bids will be opened immediately after submission deadline in the presence of Bidders' representatives who choose to attend at July 20, 2018 at the office of Pokhara-Lekhnath Metropolitan City Office, Pokhara, Kaski.
7. Bids must be valid for a period of minimum upto October 18, 2018 and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 7,60,000.00 which shall be valid minimum upto November 17, 2018.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
