Only eligible bidders *as per clause 40(2) of PPR 2064* should participate in this bidding.

- 8. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid,amounting mentioned below, which shall be valid for 30 days beyond the validity period of the bid.(i.e75 days)
